Deana Bennett continues to represent BPRO as a voting member on the Steering Committee of this workgroup along with various top State members, with Rick Waugh of this Tech Committee also on that project as a non-voting member to help provide additional information or clarification.</li> </ul> <p>We continue to make progress on the first 7 issues. We have also added 9 more issues while adding random ones that have come to be priority items. Will be implementing the rule of populate T# into MWS when Self Direct ‘thinks’ it should create a client ID so that a human eye can look at it and perform the proper file clearance. - Ability to edit registered T#s that have not started Data Collection (like case association, locality and worker).
  - **Rick Waugh submitted CR**
- Simplify Alien Screens (with the GA 2021 request for MA Unborn Child) CR681 can this be incorporated.
  - **Rick Waugh, Quinn Hughley and Natalie Jay-Short provided guide on areas of the screen needing improvements.**
- Retro Evaluation option for workers in Data Collection (if not keyed at registration)

- Allow CommonHelp documents uploaded by the client to be retrievable under T#s.

- Associate T#s to cases that are in status modes:redetermination, change/closure, add a program, etc.
  - **Rick Waugh submitted CR**
- Rescind the June 28, 2019 release item#12 that prevents anything pending to an active/pending SNAP or TANF case be transferred
  - **Rick Waugh submitted CR**
- Denial in VaCMS indicates "verification not received within time period" when we Run Elig, it would save a tremendous amount of time if VaCMS would say what screen/or what the item is that was not provided timely, rather than a worker searching every screen.
  - **Voted to move forward with CR. Rick Waugh submitted CR.**
- Allow VaCMS to PV coding for increased income resulting in a negative SNAP change, to follow policy and to allow the system to send the correct language on the NOA. Workers should not have to work around the system to get it to work using "Other VR". ADAPT allowed for the functionality and the language on the NOA.
  - **Voted to move forward with CR, awaiting further developments.**
- Ability to change case names on regular eligibility cases for SNAP/TANF and MA, as we do with EAP. Example wife dies and was the case name, husband would take over the case and the history.
  - **Will be having additional meetings to discuss further.**
